Maka dalam laporan keuangan konsolidasi akan timbul akun timbal balik antara perusahaan induk dan perusahaan anak maka harus dieliminasi, oleh karena itu diperlukan kertas kerja laporan keuangan konsolidasi. Selanjutnya dalam perjalanan proses bisnis akan terjadi transaksi antara perusahaan induk dan perusahaan anak yang berkaitan dengan (down stream or up stream): Persediaan (inventory), Aktiva tetap yang tidak dapat disusutkan (land) dan yang dapat disusutkan (plant
