The popular term denotes a situation in which one or more of these key properties reaches a point at which traditional methods for geodata collection, storage, processing, control, analysis, modelling, validation and visualisation fail to provide effective solutions. >Entering the era of big spatial data calls for finding solutions that address all “small data” issues that soon create “big data” troubles. Resilience for big spatial data means solving the heterogeneity of spatial data sources (in topics, purpose, completeness, guarantee, licensing, coverage etc.), large volumes (from gigabytes to terabytes and more), undue complexity of geo-applications and systems (i.e. combination of standalone applications with web services, mobile platforms and sensor networks), neglected automation of geodata preparation (i.e. harmonisation, fusion), insufficient control of geodata collection and distribution processes (i.e. scarcity and poor quality of metadata and metadata systems), limited analytical tool capacity (i.e. domination of traditional causal-driven analysis), low visual system performance, inefficient knowledge-discovery techniques (for transformation of vast amounts of information into tiny and essential outputs) and much more. These trends are accelerating as sensors become more ubiquitous around the world.

'Intelligent Vehicle Technologies' covers the growing field of intelligent technologies, from intelligent control systems to intelligent sensors. Systems such as in-car navigation devices and cruise control are already being introduced into modern vehicles, but

It is currently being applied successfully by scientists in over fifty countries from all the regions of the globe. This guidance is being published to share it with the wider scientific community interested in global climate change issues. This guidance document has two primary purposes: • To assist countries in making decisions about the scope and methods for their vulnerability and adaptation assessments, • To provide countries with guidance and step-by-step instructions on each of the basic elements of vulnerability and adaptation assessments.
