The twenty-first century is witnessing a resurgence and globalization of religion. Around the world, religion has become an increasingly more important and pervasive force in personal and public life, and faith and politics now play a powerful role in international affairs. This is a book by women about women in the religions of the world. Too often our curiosity about the religious faith and practices of our neighbors in "the global village" is stifled by the arcane language and philosophical hair-splitting that greets us when we open a book in search of answers to our questions. With our frustration in mind, Professors Lynn Stephens and Gregory Pence offer this insightful and engaging introduction to six of the world's major religions: Judaism, Christianity, Islam, Hinduism, Buddhism, and Confucianism. Rather than lead us through the labyrinthian history preceding the modern-day incarnations of these six traditions, Professors Stephens and Pence invite us to view the world, if only for a few moments, as we might through the eyes of someone whose religious life is very different from our own. By drawing our attention to a problem or "dilemma" central to the beliefs and rituals of a given tradition, Stephens and Pence enable us to understand how the experiences common to all of us - birth and love, faith and community, suffering and death - can become, in the actual living of these experiences, uniquely Christian or uniquely Buddhist or uniquely Jewish. For example, we learn about Christian moral thought as we puzzle over the mystery of Jesus's dual nature. We come to understand the idea of a "chosen people" by uncovering the tensions between ethnicity and universalism in Judaism. And we stretch our minds to comprehend the essence of life as we ponder the Buddhist paradox of soulless reincarnation. To be sure, we take away from *Seven Dilemmas* a keener sense of how the world appears to someone steeped in the tradition of Islam or Hinduism or Confucianism. But more than this, we realize that many of the concerns so characteristic of our religious life - the relation between religion and secular culture, the nature of God, the hope for life after death - are common to believers whose lives of faith we might otherwise have thought wholly different from our own. The real treasure Stephens and Pence offer us is the knowledge that, beneath its motley exterior, humanity yearns toward whatever truth may yield answers to the questions burning with a similar fire in every human heart.

Does any one religion have all the answers? Or must we find the answers to life's questions within ourselves? What would the Buddha think of Jesus' message of unconditional love? Would the Buddha and Jesus have any common ground? In *Jesus Meets the Buddha*, author James Kim attempts to answer these questions and many more by exploring the histories and beliefs of two of the world's major religions: Christianity and Buddhism. Driven by his own desire to answer questions such as "Who am I?" and "Why am I here?" Kim builds on the discourses of the world's greatest thinkers to examine religions and philosophies, including Judaism, Hinduism, Confucianism, and even Voodoo. His conclusion is that every religion in existence today is a precious gem of human history and an irreplaceable facet of the

giant mosaic that makes up our world. He argues that by combining Jesus' teaching with the long-held ethical and religious traditions of the East, we can build a meaningful unity for humankind. Provocative and well-researched, *Jesus Meets the Buddha* is a must-read book for anyone interested in the world's religions or who is looking for their own answers about their place in the universe.

Philosophically *Thinking about World Religions* is different from other works in the discipline today. It deviates from the typical approaches used for the study of world religions. Its goal is to engage readers in thinking hard about world religions, not about the data surrounding those traditions. By focusing on philosophical questions, each reader should be challenged to do their own investigations that may reveal the heart of these traditions. Another stance that this project takes that distinguishes it from other texts in the discipline is that it advocates an inclusivist perspective regarding the world religions. Pluralism, which is the predominate assumption today, ends either in contradiction or in the development of a metatheory that dismisses crucial distinctions between the various traditions or eliminates some ancient religions because they do not fit the metatheory. By taking an open inclusivist approach, all religious traditions may engage at the table of dialogue. The final essay is about justice and social affairs. While that discussion is couched within the context of a particular tradition, each religious tradition must have the discussion. But it must be more than an intrareligious dialogue; it must become an interreligious dialogue.
