AN ACT to legalize the act of the board of supervisors and county auditor and the vote of the people of Polk county in relation to levying a tax to raise funds to build an asylum in said county for the care of the insane. Whereas, The board of supervisors of Polk county, Iowa, submitted a proposition to the electors of said county at the general election of November 3, 1896, touching the erection of a county asylum for the insane, and the levying of a tax to make payment therefor; and Whereas, Doubts have arisen as to the validity of the election resulting in favor of the erection of said asylum and the levying of said tax, because of the failure to give notice of said election and the result thereof, and otherwise, as by law required; therefore, Be it enacted by the General Assembly of the State of Iowa: Section 1. That said election and the result thereof, and all acts of the said board of supervisors and said county auditor in connection therewith, or based thereupon, be, and the same hereby are, legalized and made valid, and shall have the same force and effect in all respects as if no error, irregularity, or omission had occurred in connection therewith. This act being deemed of immediate importance, the same shall be in full force and effect from and after its publication in the Iowa State Register and the Des Moines Leader, newspapers published at Des Moines, Iowa, without exper se to the state. Volume 4 deals with the Social Dimension of the Bible. It defines the four social institutions created by God: the family, human government, the Nation of Israel, and the Church, and describes how the Universal Principles discovered in Volume 2 may be or have been applied in those four social institutions. Volume 5 summarizes the bottom-line conclusions and recommendations from the scientific analysis of the four dimensions of the Bible, and it defines the meaning of the symbols that are used to represent the Universal Principles.
