This book aims to explain to the readers the basic idea of the general equilibrium theory, which forms the core of the current mainstream economics called neoclassical school. To understand this theory is absolutely necessary, either to study further or to criticize the contemporary economic theories. The author not only explains traditional theories, but also makes clear the many problems which are still unsolved. As a text book or reference book for those students who are studying microeconomics for the first time, the author recommends the use of Chapter 1, Chapter 2 (except section 9), Chapter 3 (from section 1 to section 3, section 6, section 11), Chapter 4 (from section 1 to section 4), Chapter 5 (from section 1 to section 5, section 8), Chapter 6 (except sections 6 and 7), Chapter 7 (from section 1 to section 5), Chapter 8 (from section 1 to section 6) and Chapter 9 (sections 1, 4 and 7). For more advanced readers, the author recommends the remaining sections and the literature recommended in the last part of each chapter. Problems given at the end of each chapter allow readers to confirm understanding of the content of the chapter and suggest to the readers more advanced studies. Incidentally, the author tried to avoid the use of the advanced mathematics. Only elementary knowledge of differential calculus and linear algebra are required to read this book.

Wangga, originating in the Daly region of Australia's Top End, is one of the most prominent Indigenous genres of public dance-songs. This book focuses on the songmen who created and performed the songs for their own communities and for the general public over the past 50 years. The book is organised around six repertoires: four from the Belyuen-based songmen Banttjap, Muluk, Mandji and Lambudju, and two from the Wadeye-based Walakandha and Ma-yawa wangga groups, the repertoires being named after the ancestral song-giving ghosts of the Marri Tjavin and Marri Ammu people respectively. Framing chapters include discussion of the genre's social history, musical conventions and the five highly endangered languages in which the songs are composed. The core of the book is a compendium of recordings, transcriptions, translations and explanations of over 150 song items. Thanks to permissions from the composers' families and a variety of archives and recordists, this corpus includes almost every wangga song ever recorded in the Daly region. Representing the fruit of more than 20 years' work by Marett, Barwick and Ford with the families of the songmen, and drawing on a rich archival record of photographs and recordings from the communities of Belyuen and Wadeye, this book is the first phase of a multimedia publication project that will also include a website and a series of CD packages. It is the second book in the series 'The Indigenous Music of Australia' published by Sydney University Press. All the recordings are available to stream.

Examination of literature on strategic thinking does not lead to one common definition of strategic thinking. However, there are some identified

common attributes of strategic thinking. Strategic thinking is built on a systems perspective, intent driven, hypothesis driven, intelligently opportunistic (capitalizing on new possibilities as the situation changes), and involves the ability to think in time (linking past, present, and future elements). The confusion about the definition of strategic thinking is exacerbated by the confounded concepts of strategic thinking, strategic planning, strategy, and the strategic thinker. In addition to the lack of common definition of strategic thinking, Heracleous notes that there is no common definition of strategic planning or common understanding of the relationship between strategic thinking and strategic planning. Liedtka outlines several differences between strategic thinking and strategic planning that include reliance on systems thinking, the role of measurement and control, and a focus on the outcome (strategy) versus the process. For the purpose of this compendium, we have focused extensively on concepts related to strategic thinking (cognitive processes) and the strategic thinker (characteristics of a person). This work does not extensively address the concepts of strategy (outcome) or strategic planning (programmatic, analytical process). Strategic thinking in the military comes with unique challenges and opportunities. It is different than strategic thinking in the private sector.
