The 'resource boom' that took place in the early years of the current century has only served to intensify the political contests and conflicts that surround the distribution of social, economic and environmental costs and benefits between community members and other 'stakeholders' in the large-scale mining industry. However, the mutual isolation of Anglophone and Francophone scholars has formed a barrier to systematic comparison of the relationship between large-scale mines and local-level politics in Papua New Guinea and New Caledonia, despite their geographical proximity. This collection of essays represents an effort to overcome this barrier, but is also intended as a major contribution to the growth of academic and political debate about the social impact of the large-scale mining industry in Melanesia and beyond.

*Crystals and Crystal Structures* is an introductory text for students and others who need to understand the subject without necessarily becoming crystallographers. Using the book will enable students to read scientific papers and articles describing a crystal structure or use crystallographic databases with confidence and understanding. Reflecting the interdisciplinary nature of the subject the book includes a variety of applications as diverse as the relationship between physical properties and symmetry, and molecular and protein crystallography. As well as covering the basics the book contains an introduction to areas of crystallography, such as modulated structures and quasicrystals, and protein crystallography, which are the subject of important and active research.
