English law is uncodified, this means that the laws of certain areas of law are not systematically bundled into one specific code. Basically, the English law is composed of three elements: directly enforceable EU law, common law and legislation created through Parliament whereas the latter is the highest form of UK law. Under British Constitutional Law the Parliament is sovereign. Following the traditional interpretation of Parliament Sovereignty "it has the power to make any statutes on any subject matter, and British courts are bound to enforce that laws" without questioning their validity.
