The suburb of Wigford lies near the heart of the historic city of Lincoln. Before excavations began in 1972, nothing was known of the prehistory of the area and so the arrival of the Roman army represented the first historic event. This volume publishes the results of the excavation of several sites, made possible by a series of urban development schemes. Each of the excavations differed in the extent and depth of the stratigraphy uncovered and each belonged to a different period, from the Iron Age to post-medieval.

Reanimating Industrial Spaces explores the relationships between people and the places of former industry through approaches that incorporate and critique memory-work. The chapters in this volume consider four broad questions: What is the relationship between industrial heritage and memory? How is memory involved in the process of place-making in regards to industrial spaces? What are the strengths and pitfalls of conducting memory-work? What can be learned from cross-disciplinary perspectives and methods? The contributors have created a set of diverse case studies (including iron-smelting in Uganda, Puerto Rican sugar mills and concrete factories in Albania) which examine differing socio-economic contexts and approaches to industrial spaces both in the past and in contemporary society. A range of memory-work is also illustrated: from ethnography, oral history, digital technologies, excavation, and archival and documentary research.

Today, we are surrounded by the physical legacy of over two centuries of industrialisation: factories, canals, industrial towns and cities. By the 1950s, some of these relics of early industry began to take on a new significance: they were seen as an archaeological and historical reflection that needed to be captured, by recording and occasionally preservation. Industrial archaeology arose out of a widespread recognition of this need. In this book, distinguished authors review developments in industrial archaeology in Britain from the mid-1950s, when the term first appeared in print, to the present and offer some prospects for the future. Publication coincided with the International Congress on the Conservation of the Industrial Heritage held in Britain in 2000.

Industrial archaeology is the study of early industrial buildings and machinery, particularly of the eighteenth and nineteenth centuries. When this book was originally published in 1963, this was becoming a topic of lively interest and controversy among archaeologists, historians, architects and engineers. This book discusses the aims and methods of the science, giving examples of the contribution which different kinds of specialists can make. This shows a fascinating slice of the history of the discipline of archaeology as well as offering insights into industrial archaeology when the term was first being used. As the first text on the subject, this book also lead to the start of the industrial archaeology movement in the USA.

This book provides a twenty-first century perspective on Roman Britain, combining current approaches with the wealth of archaeological
