As citizens, we must all take responsibility for our own health to some extent, and recent developments in medical informatics have provided some valuable new ways to

help us do that. This book presents the proceedings of the 2020 Special Topic Conference of the European Federation for Medical Informatics (EFMI STC 2020), held for the first time as a virtual conference on 26 & 27 November 2020, due to restrictions associated with the COVID-19 pandemic. Entitled Integrated citizen centered digital health and social care – Citizens as data producers and service co-creators, this conference focused on the citizen-centered aspects of health informatics. The 84 revised papers included in this volume were carefully reviewed and selected from 358 submissions. The volume establishes positioning primarily as the negotiation of interpersonal relationships, and draws on concepts from across disciplines by way of reappraisal before applying them to two specific domains: MMORPGs (Massively Multiplayer Online Role-Playing Games) and private ELF couple interaction. While acknowledging and showcasing the unique features of positioning in these two contexts, Klötzl and Swoboda point to their commonalities by looking at how language and specifically English is used as a communicative resource in lingua franca situations. The book also identifies new directions for future methodological innovations in that it demonstrates how the same interaction can be looked at in methodologically-different ways and how the authors' own positions projected on to such interaction create an integrated tri-partite perspective on the two domains. Shedding light on interpersonal positioning in different contexts and in turn on global communication more generally, this book will be of particular interest to students and researchers in discourse analysis, pragmatics, computer-mediated communication, sociolinguistics, and applied linguistics.

Fratricide has been defined as firing on your own forces, when mistaking them for enemy forces, which results in injury or death. Rates of fratricide incidence have been steadily increasing and the complexity of the contemporary operating environment may lead to a continuation of this trend. Although the majority of research into fratricide has

focused on the development of technological decision aids, recent explorations highlight the need to emphasise the social aspects within a socio-technical framework. This book presents and validates, via the use of case studies, a model of teamwork and decision-making factors that are associated with incidents of fratricide. In summary, it offers a review and evaluation of contemporary theoretical perspectives on teamwork and fratricide, as well as a range of accident analysis approaches. A novel theory of fratricide is then presented followed by a new methodology for assessing fratricide. Naturalistic case studies of teams are undertaken in the military domain. These studies illustrate the approach and offer early validation evidence. In closing, the book presents a series of principles designed to reduce the likelihood of fratricide in the future.

After introducing the dusky dolphin as a member of the genus *Lagenorhynchus* under the family Delphinidae, the book continues by describing its life history, its demographic patterns, and its role in the food web considering predation, parasitism, and competition. The book also includes chapters that discuss the interaction of the dusky dolphin with its habitats, such as the dusky dolphin's sound production, its foraging at night and in daylight, its survival strategies in response to predator threats, the mating habits of New Zealand duskies, calf rearing, sexual segregation, and genetic relationships. Other chapters address the interaction of dusky

dolphins with humans. This book offers information about dusky dolphins off Southern Africa and discussions about the patterns of sympatry in *Lagenorhynchus* and *Cephalorhynchus*. Finally, comparisons between dusky dolphins and great apes as large-brained mammals are also reviewed in this book. This ethnographic study deals with the ways people in Athens, Greece, use style to construct their social class identities. Including a rich dataset comprising ethnographic interviews with actual people who live in the stereotypically seen as leafy and posh northern suburbs and in the stereotypically treated as working class western suburbs of Athens coupled with data from popular literary novels, TV series and Greek hip hop music, it argues that the relationship between style and social class identity is mediated

by complex social meanings encompassing features from and discourses relevant to both areas, which are structured across different orders of indexicality depending on the genre of speech in which they are created. As such, it will be of interest to scholars in sociolinguistics, discourse analysis, anthropology, sociology, Modern Greek studies, and to everyone who is interested in how social class is constructed via language. Based on ethnographic research, this book examines the paranormal investigation subculture in the US. Presenting interviews with investigators as well as extensive field observations, it explores their reasons for getting involved, their use of different investigative methods, the interpretive processes by which they individually and collectively 'sense' spirits, the ways in which these processes are influenced by small group power dynamics, and what paranormal investigation ultimately means to those who participate. While focusing on the practices by which investigators 'sense' spirits in small groups, the author also situates paranormal investigation within a broader cultural context and attends to how investigators attempt to legitimize their practice despite being marginalized by both science and religion. A fascinating study of ghosts as an inherently social phenomenon, *Sensing Spirits* will appeal to sociologists with interests in ethnography, interactionism, cultural studies and subcultures. Organizational leaders often struggle to establish and sustain a trusting culture in

times of constant changes in the corporate fabric and unethical behavior by corporate leadership. Organizational justice theory provides a means to explain and better understand employees' perceptions of trust, fairness, and the management of change during strategic change. Qualitative studies have yet to be conducted on how an organizational justice framework would address the need of organizational justice for novel, conceptually derived accounts of non-managerial employee perspectives. The purpose of Organizational Justice during Strategic Change is to be both an academic and practical book. After presenting the theoretical elements of the topic, half the book is devoted to a detailed case study of employee interviews conducted in a large, privately-owned media organization addressing the issues of the book topic. The authors' research findings from the case study indicated employees who experience trust and positive feelings regarding their treatment within the organization are willing to become involved in the change process and adopt positive working relationships with their colleagues and managers. This study is important for organizational management to gain knowledge and understanding on how employees' perceptions of distrust and unfairness can lead to resistance and negative behaviors toward organizations and management during strategic change. "The book is concerned with the interaction of syntax, information structure and

prosody in the history of English, demonstrating this with a case study of object topicalization. The approach is data-oriented, using material from syntactically parsed digital corpora of Old, Middle and Early Modern English, which serve as a solid foundation for conclusions. The use of object topicalization underwent a sharp decline from Old English until today. In the present volume, a basic prosodic well-formedness condition, the Clash Avoidance Requirement, is identified as the main factor for this change. With the loss of V2-syntax, object topicalization led more easily to cases in which two focalized phrases, the topicalized object and the subject, are adjacent. The two focal accents on these phrases would produce a clash, thus violating the Clash Avoidance Requirement. In order to circumvent this, the use of topicalization in critical cases is avoided. The Clash Avoidance Requirement is highly relevant also today, as experimental data on English and German show. Further, the Clash Avoidance Requirement helps to explain the well-known syntactic structure of the left periphery in Old English. An analysis positing two subject positions is defended in the study. The variation of these subject positions is shown to depend not on pronominal vs. lexical status of the subject but on information structural properties."--Publisher's website.
