PREFACE Within the Florida Everglades, tree islands, which cover only a small percent of this ecosystem, historically have provided essential habitat for a wide variety of terrestrial and amphibious plants, birds, and animals. These tree islands, however, have been one of its least studied features. Because of their less flood tolerant vegetation, tree islands are one of the most sensitive components of the Everglades to changes in hydrology, and many tree islands have been lost during periods when water levels have been abnormally high or low. Their sensitivity to water level changes makes tree islands potentially one of the best and surest measures of the overall hydrologic health of the Everglades. Consequently, the maintenance of healthy, functioning tree islands and the restoration of those that have been lost will be an important performance measure that will be used to judge the success of the Comprehensive Everglades Restoration Plan (CERP). A symposium, Tree Islands of the Everglades, was held on July 14 and 15, 1998 at Florida Atlantic University, Boca Raton, Florida. It was sponsored by Florida Center for Environmental Studies and the South Florida Water Management District. This was the first scientific meeting ever devoted to tree islands.
