With these plans of renovation came the importance of education - as the development of the Outlook Tower, his numerous summer schools and his Collège des Ecosais in Montpellier illustrate. It is in India where his name is most widely known. It was here that possibly the greatest example of Geddes' belief in 'people planning' can be seen and which took the form of pedestrian zones, student accommodation for women, and urban diversification projects in Edinburgh. Indeed, his influence travelled around the world, through the people he met and inspired, and has survived after his death.
