Urban populations are projected to increase from 54% to 66% of the global population by 2050, with close to 90% of the increase concentrated in Asia and Africa. This book details the process of design whereby the inspiration for a bridge is developed into the final reality of the built solution. It looks at the functions of a bridge, defining purpose of place and context, the spirit of creativity and the reasoned progression of an idea. It also explores the exploitation of materials technology and construction innovation, and the tension between lightness and mass and between sculpture and scale.
