Sport sponsorship contracts become evermore important and lucrative (expensive), however it is not clear whether investors support this trend. This study aims to analyze investors' reactions on the stock market when a sport sponsorship agreement with a German company is announced. The German market is tested as it is very special, because of the investors' sentiment and the relatively low free float (Finter, Niessen-Ruenzi, & Ruenzi, 2011) and also because no other study regarding this topic has focused on this market, yet. After conducting an event study with a unique sample of 87 announcements which are dated from 2000 to 2017 the results reveal no significant abnormal returns, but a positive drift on and after the day of announcement. However, a linear regression with various variables shows that companies that are from the same region as the sponsee and contracts which are made with soccer related organizations are positively related to the stock price of the sponsor. On the other hand the value of the company is negatively related to the share price reactions. The relation between stock price development and sports teams which are abroad, congruence, contract price, contract length, new contracts, the amount of cash of the

sponsor, becoming the main sponsor and the value of sport teams are ambiguous or not significant. These results suggest that, under certain circumstances, sports sponsorship may be a worthwhile investment for German companies.
