On the surface, Riverview High School looks like the post-racial ideal. Serving an enviably affluent, diverse, and liberal district, the school is well-funded, its teachers are well-trained, and many of its students are high achieving. Yet Riverview has not escaped the same unrelenting question that plagues schools throughout America: why is it that even when all of the circumstances seem right, black and Latino students continue to lag behind their peers? Through five years' worth of interviews and data-gathering at Riverview, John Diamond and Amanda Lewis have created a rich and disturbing portrait of the achievement gap that persists more than fifty years after the formal dismantling of segregation. As students progress from elementary school to middle school to high school, their level of academic achievement increasingly tracks along racial lines, with white and Asian students maintaining higher GPAs and standardized testing scores, taking more advanced classes, and attaining better college admission results than their black and Latino counterparts. Most research to date has focused on the role of poverty, family stability, and other external influences in explaining poor performance at school, especially in urban contexts. Diamond and Lewis instead situate their research in a suburban school, and look at what factors within the school itself could be causing the disparity. Most crucially, they challenge many common explanations of the 'racial achievement gap,' exploring what race actually means in this situation, and why it matters. An in-depth study with far-reaching consequences, *Despite the Best Intentions* revolutionizes our understanding of both the knotty problem of academic disparities and the larger question of the color line in American society.

This publication examines whether Ecstasy (MDMA) is neurotoxic in humans and comprises research papers from a Novartis Foundation Discussion Meeting on this topic. Leading researchers from around the world were invited to debate this issue. Five speakers (George Ricaurte, Una McCann, Andy Parrott, Fabrizio Schifano, Valerie Curran) present review papers on the latest empirical data. These presentations show that repeated use of MDMA can cause prolonged neural damage in laboratory mammals, and outline the increasing body of evidence for MDMA-induced neurotoxicity in humans. Recreational Ecstasy users, assessed when drug-free, sometimes display the following deficits: reduced levels of serotonin metabolite 5-HIAA; PET scan indications of reduced serotonin axon-terminal density; selective cognitive deficits in tasks involving memory and higher executive processing; and various psychiatric disorders. Every participant at the discussion meeting was also invited to answer the core question in an abstract. The five invited papers together with all the abstracts, are presented here. This special issue, aimed at psychiatrists, psychologists and neurologists, summarizes the methodological problems and uncertainties in this field of research. Generally, it concludes that MDMA is not a safe drug, with many regular Ecstasy users suffering neuropsychobiological problems.

Each author addresses how the unique social and cultural position Black students occupy—in a society which often devalues and stereotypes African-American identity—fundamentally shapes students' experience of school and sets up unique obstacles. Young, Gifted and Black provides an understanding of how these forces work, opening the door to practical, powerful methods for promoting high achievement at all levels. In the first piece, Theresa Perry argues that the dilemmas

African-American students face are rooted in the experience of race and ethnicity in America, making the task of achievement distinctive and difficult. She uncovers a rich, powerful African-American philosophy of education by reading African-American narratives from Frederick Douglass to Maya Angelou and carefully critiques the most popular theoretical explanations for group differences in achievement. She goes on to lay out how today's educators can draw from these sources to reorganize the school experience of African-American students. Claude Steele follows up with stunningly clear empirical psychological evidence that when Black students believe they are being judged as members of a stereotyped group—rather than as individuals—they do worse on tests. He analyzes the subtle psychology of this 'stereotype threat' and reflects on the broad implications of his research for education, suggesting scientifically proven techniques that teachers, mentors, and schools can use to counter the powerful effect of stereotype threat. Finally, Asa Hilliard's essay argues against a variety of false theories and misguided views of African-American achievement. She also shares examples of real schools, programs, and teachers around the country that allow African-American students to achieve at high levels, describing what they are like and what makes them work. Now more than ever, *Young, Gifted and Black* is an eye-opening work that has the power to not only change how we talk and think about African-American student achievement but how we view the African-American experience as a whole.
