Oral Pathology as part of the Head and Neck Pathology is an interdisciplinary field of science. The oral mucosa and the saliva are reflectors of many systemic diseases of the organism and therefore valuable parameters of the diagnosis and prognosis of pathological processes. Improving understanding of the extent, causes, effects, and prevention of sports-related concussions is vitally important for the health and well-
